The IT Area Lead will report to the Head of IT Customer & Data and work closely with the Tribe Lead of the Data Management Tribe and the Product Leads.

One of the primary responsibilities of the IT Area Lead will be to design and drive a transformation of the data architecture and associated way of working. They will develop the target architecture, including cloud services, data modeling, and a data analytics environment, and lead its step-by-step implementation. In developing the architecture, the IT Area Lead will work closely with teams from Global. Additionally, they will introduce a modular approach to multidisciplinary collaboration, establishing efficient teamwork between the data and IT experts and the business. Their efforts will create a first-class agile working environment, attract and retain the best engineers, and encourage innovative thinking around data, analytics, and Al.
