International Finance director

The current Finance Director will fill the position of Group Finance Director and the company is looking for an International Finance Director. He/she has 10 direct reports, which are local Finance & Control Managers, who each manage a team of 2 to 20 people. In total, the Finance Director is responsible for around 80 employees. He/she reports to Hans Scholten, CFO.

People management and leadership are important capabilities that the International Finance Director has in store. He/she does not just simply manage the local finance organizations but actively builds high performing teams.
