

Atida is backed by the London-based healthcare investor MARCOL. The scale-up is the sum of the acquisition of seven online pharmacies in Germany, Spain, and Portugal over the past fifteen years. The company has around 600 employees of which five percent work from the Amsterdam-based headquarters.
