It serves a broad range of sectors, including food, automotive, retail, and industrial manufacturing, ensuring goods move safely, efficiently, and reliably across Europe.**

Rotom offers more than just products. Its value-added services – such as pallet pooling, return logistics, repairs, and on-site recovery – help customers reduce waste, improve transport flows, and lower their carbon footprint. To deliver these services effectively, the company combines a strong local presence with international reach, offering flexible and cost-effective logistics solutions tailored to each customer's needs. Headquartered in Son, The Netherlands, Rotom operates over thirty sites across eleven European countries. With more than 850 employees, it serves a diverse and growing customer base.
